Dear Leader McConnell, Minority Leader Schumer, Chairman Grassley, and Ranking Member Wyden,

We the undersigned organizations representing clinical care providers and advocacy organizations are writing to express our deep concern with the fundamental changes to Medicare Part B that the committee is considering.

As the committee is aware, Part B medicines are vital to treating seniors and individuals living with conditions that require intensive management, such as cancer, rheumatoid arthritis, macular degeneration, Crohn's disease, or immunodeficiency diseases. This coverage is critical, and several of the policies the committee is considering could have a negative impact on patient access.

These policies include inclusion of copay coupons in the calculation of provider reimbursement. These programs provide vital assistance to patients facing high out of pocket costs and their inclusion in the ASP calculation could have unintended consequences for patient access. This policy change will decrease reimbursement to providers and could challenge the viability of practices, especially those in rural or underserved areas, potentially causing closures, consolidations, and other access to care issues. Additionally, the proposed cap on provider reimbursement for these medications fail to take into account the specialized storage, handling, and patient monitoring requirements for these complex therapies.

Finally, these policies are in addition to the continuation of sequester cuts that many providers already face, as well as the threatened lowering of reimbursement that would come from the proposed International Pricing Index.

Policies the committee is considering put program costs before the health of patients living with serious illness, and rely on Medicare Part B. These policies are aimed at reducing government costs, without addressing the needs of beneficiaries. We therefore strongly urge the committee to reconsider.
